

Town of North Yarmouth Board of Selectmen Meeting Minutes of Tuesday, July 7, 2015

I. Call to Order

Members Present: Chairman Steve Palmer, Mark Girard, Alex Carr and Jeanne Chadbourne. Town Manager Rosemary Roy was also present.

II. Organization of the Board

<u>Election of Chair</u> – Prior to taking a vote Selectpersons nominated Selectperson Chadbourne and Selectman Girard for Chair of the Board. Prior to taking a vote Selectman Girard made a motion to suspend the bylaws. There was no second on the motion no action taken. The board then voted by secret ballot on the nominations resulting in 2 votes for Selectperson Chadbourne and 2 votes from Selectman Girard. Chairman Palmer had a brief explanation that according to the statute the Chairman cannot appoint a new chair therefore resulting in the Town Clerk entering names into a jar and having a member of the public draw a random. **Selectman Carr was selected and accepted the appointment.**

1. Must be rebuilt within the calendar-year no later than 2017

2. All-insurance money is to go into the reconstruction of the building and meet all the taken out-concensus of Board ~ criteria of the 1997 acceptance agreement.

3. The facility shall-be rebuilt-modeling the old-building.

- 5. Facility needs to be positioned on the same campus as the Town Office.

Chairman Carr informed the public that the Board decided to opened the Budget Committee seat up for the special election to be held 9/21/15.
