

Town of North Yarmouth Board of Selectmen Meeting Minutes of Tuesday, October 20, 2015

I. Call to Order

Members Present: Chairman Alex Carr, Mark Girard, Steve Palmer, Jeanne Chadbourne & Jim Moulton. Town Manager Rosemary Roy was also present.

II. Public Hearing – Fee Schedule – Amendments

Selectman Palmer moved to open the Public Hearing regarding the Fee Schedule. Selectman Girard seconded the motion. Discussion: None. **Vote: 5- Yes 0- No**.

Town Manager Roy gave the Board a brief overview in regards to the fee schedule.

Yarmouth Water District Correspondence- Discussion: Selectman Girard presented the letter sent to the Board. Selectman Palmer moved to review and send the letter drafted as a response to the Yarmouth Water District's letter. Selectman Girard seconded the motion. Discussion: The Board discussed the letter. Selectman Palmer amended his motion to have the Town Manager draft and send the letter in response to the Water District. Selectman Moulton seconded the motion. Discussion: None. Vote: 4- Yes 1- No (Chairman Carr). Selectman Palmer made a motion to reconsider the amendment that passed. Selectman Girard seconded the motion. Vote: 4- Yes 1- No (Selectperson Chadbourne). Selectman Palmer withdrew his original motion. Selectman Girard withdrew his second to the original motion. Selectman Palmer made a motion to authorize the Town Manager to write a response letter to the Yarmouth Water District. Selectman Girard seconded the motion. Discussion: Selectman Moulton clarified that the letter would come from the Town Manager. Vote: 3- Yes 2- No (Chairman Carr & Selectman Moulton).
