# Town of North Yarmouth Board of Selectmen Meeting Minutes of Tuesday, October 6, 2015



## I. Call to Order

Members Present: Chairman Alex Carr, Mark Girard, Steve Palmer, Jeanne Chadbourne & Jim Moulton. Town Manager Rosemary Roy was also present.

II. <u>Public Hearing</u> – General Assistance Ordinance – Amendments
Selectman Palmer moved to open the Public Hearing regarding the General Assistance Ordinance
Rates, Selectman Girard seconded the motion, Discussion; None, **Vote: 5- Yes 0- No**.

Chairman Carr asked if there were any comments from the public. There was no public comment. Selectman Girard moved to close the Public Hearing. Selectman Palmer seconded the motion. Discussion: None. **Vote 5- Yes 0- No.** 

Selectman Girard moved to adopt the amendments to the General Assistance Ordinance. Selectman Palmer seconded the motion. Discussion: Selectman Moulton inquired if this was following state mandates. **Vote: 5-Yes 0-No.** 

## III. Minutes of Previous Meeting(s)

Selectperson Chadbourne moved to approve the minutes of September 15. Selectman Palmer seconded the motion. Discussion: Selectman Palmer noted a correction of the name of the conference he attended was Summit on Aging. He noted that he never gave an overview on the cost analysis he just suggested a recommendation for the cost analysis. **Vote: 4- Yes 0- No 1- Abstention (Selectman Moulton).**

Selectman Moulton moved to accept the October 27, 2015 date for the informational meeting to be put on the post card. Selectperson Chadbourne seconded the motion. Discussion: Selectman Palmer asked for clarification on the first motion.

Chairman Carr moved to reconsider the previous motion regarding the fee being waived. Selectperson Chadbourne seconded the motion. **Vote: 5- Yes 0- No.** 

Selectperson Chadbourne moved to waive the fee for the citizen's petition group to hold their meeting. Selectman Moulton seconded the motion. Discussion: None. **Vote: 3- Yes 2- No.** 

Selectman Moulton moved to include line four (4) October 27, 2015 Public Informational Meeting on the post card. Selectperson Chadbourne seconded the motion. Discussion: None. **Vote: 3- Yes 1- No 1- Abstention (Selectman Palmer).** 

<u>Quarterly Financial Report</u>- The Board reviewed the Quarterly Financial Report and briefly discussed the report.

<u>Proposed Fee Schedule Amendments Final Review & Set Public Hearing Date:</u> The Town Manager gave an overview to the Board regarding the fee schedule. <u>Assessing Service</u> - RFP Draft: The Town Manager asked for comments or suggestions from the Board. Selectman Palmer proposed taking care of the interview process and making a selection for the December 1, 2015 meeting. Chairman Carr agreed with Selectman Palmer's proposal on or about the December meeting and recommended scheduling it into workshops held in November.

<u>Cumberland County Sheriff's Department</u> – NY Coverage Inquiry: The Town Manager informed the Board about the informational request regarding coverage specifically on the North Road. Selectman Moulton suggested posting signs about passing on North Road.

#### IX. Accounts Pavable- Review & Approval

Selectman Palmer moved to approve the town payable of and payroll of \$655,183.36. Selectman Girard seconded the motion. Discussion: The Town Manager noted a bill from the attorney she is holding for further clarification. **Vote: 5- Yes 0- No.**

Selectperson Chadbourne noted there was a significant meeting from Aging in Place coming up.

Selectman Girard noted that a couple public comments from earlier in the meeting were factually incorrect.
