**Organize Celebrate our Parks -** LWNY would like to collaborate with other committees, such as Parks & Rec Ex: Pick a Park - plan an activity in each town park

Old Town House Park, Chandler Brook, Sam Ristich Trail, Knights Pond, Baston Park. Ideas generated: marshmallow roast, scavenger hunt, ice skating, snow shoeing. Steve will reach out to Parks & Rec Committee and ask if a couple members of LWNY could attend their December meeting to see if they have interest in collaborating with us to celebrate our parks. Parks are major attributes to our town and planning activities in the parks adds to living well in North Yarmouth.
