Alternate Board Member Alexander Urquhart, seconded by Board Member Sanford Peabody, motioned to accept the recusal of Board Chair Paul Whitmarsh from the Deacon Hayes remand item. Vote 2 yes/0 no.

Board Chair Paul Whitmarsh announced that the Deacon Hayes ZBA remand item would be addressed at a later date as there was not a quorum.

Board Chair Paul Whitmarsh read from the emails that provided legal opinion on Boundary Line Solar.

Board Chair Paul Whitmarsh, seconded by Board Member Sanford Peabody, motioned to approve Boundary Line Solar Site Plan. Vote 3 yes/0 no.

Adjournment (1:24:52 – 1:25:00) Alternate Board Member Alexander Urquhart, seconded by Board Member Sanford Peabody, motioned to adjourn the meeting at 7:40pm. Vote 3 yes/0 no.
