Governor's Proposed Budget

The public is invited to attend a community forum to learn more about the governor's proposed state budget and its impact on Maine residents, municipalities, businesses, and organizations.

Senator Stan Gerzofsky will host the event in an effort to hear from residents of North Yarmouth and Pownal.

"It's important for me to hear from my constituents," said Gerzofsky. "This budget contains proposals that will have an effect on the lives of the people I represent. I want to make sure they are aware of the potential impact of these proposals."

Governor Paul LePage submitted his state budget proposal at the beginning of the year and the Legislature's Appropriations and Financial Affairs Committee is now reviewing the \$6.5 billion document. After a thorough process of months of public hearings, public testimony, and work sessions, the budget-writing committee will provide its recommendation to the full Legislature for consideration.

The forum will be held at the North Yarmouth Memorial School (Room 12) on Thursday, April 16th at 7:00 p.m. The public is asked to use the side entrance off the parking lot.

Heads Up:

The Yarmouth Water District's infrastructure expenditures require a rate increase of approximately \$6.90 per month on the average household bill.

During the past three years, expensive State required MDOT projects on local bridges and roads have mandated unscheduled main replacements. During that time frame, the District identified a critical water main had become grossly tuberculated; it is located near schools. The tuberculation greatly limited the necessary fire flows and thus required major maintenance on an early 1900's pipeline.

Needless to say, all these unplanned projects resulted in large capital infrastructure investments, which, in turn, required bonding of the obligatory capital and the scheduling of its repayment. In addition, the installation of the new Summit gas utility within our service area impacted our operational costs substantially, and we don't see the demand for location services and installation monitoring diminishing within the immediate future.

In fact, we project an increase in similar externalities for the near term, especially when infrastructure funding from the Federal Government through to the States occurs. It will cause a repeat of the above 2-to-3 year cycle, which will require increasing our capital re-investments, and may require another similar increase in rate funding.

Watch for the scheduling of the legal process: a Maine Public Utility Commission rate case. The District will be notifying all customers of its filing, information and new rate schedules.


