Over the next couple of days you will be receiving a Personal Property Declaration Notice from the town's Tax Assessor.

According to state law the tax assessors are required to obtain this information from all residents.

It recently came to our attention that the residential personal property had not been updated on a regular basis. Therefore in an effort to ensure North Yarmouth's compliance with taxation laws.

Sections of the Maine personal property tax law are included in the mailing. Information explains law and what is considered to be an exemption.
