GREETINGS: You are hereby notified that the Municipal Election, set forth in Articles 2 - 4 of this Warrant, will be determined by secret ballot by a vote in conformity with sections 2528 to 2532 of Title 30-A of the Maine Revised Statutes, as amended, at the Church of Jesus Christ of Latter-day Saints, 247 Walnut Hill Road, North Yarmouth, Maine on Tuesday the 11th day of June 2019. The polls will be open between the hours of 7:00 AM and 8:00 PM.

The Registrar of Voters, Debbie Allen Grover, gives notice that the registrar's office will be in session from 7:00 AM to 8:00 PM at the North Yarmouth Memorial School on Tuesday, June 11, 2019 for the purpose of registering new voters and correcting the current list of voters.

**ARTICLE 1. To choose a Moderator to preside at said Special Town Meeting and Election.**

**ARTICLE 2.** To elect by secret ballot:

- a) Two (2) Selectman/Overseer of the Poor for terms of three (3) years;
- b) One (1) MSAD #51 Board of Directors for a term of three (3) years;
- c) One (1) Cemetery Commission Member for a term of five (5) years;
- d) Two (2) Budget Committee Members for terms of three (3) years; and
- e) Two (2) Budget Committee Members for terms of two (2) years.


