# Special Town Meeting

Tuesday, August 8, 2017 6:30 p.m. Memorial School Gym

#### PLEASE REMEMBER

Absentee voting is not available at this meeting.

You MUST be present to vote.



**ARTICLE 2.** To see if the Town will vote to repeal **Article 3, Question 2, § C)** taken at the Special Town Meeting held on November 3, 2015, authorizing the Select Board to "retain the current Town Hall and land. Make renovations and additions to the building as needed over time for municipal purposes."

**ARTICLE 3.** To see if the Town will vote to authorize the Select Board to transfer an amount of **\$65,000** from the Town's unassigned fund balance to be placed in a dedicated fund balance account to be expended for the purpose of architectural contractual costs for the design and engineering of a new Town Office facility or see what action the Town will take. (*Approval of this article will not increase the property tax levy.*)

At this Special Town Meeting, voters will decide whether to transfer \$65,000 from the Town's unassigned fund balance to design a new Town Office on the Memorial School site. In order to do that, voters will also need to vote to repeal a portion of the November 2015 vote that mandated retaining and renovating the Town Office at its existing location.

#### AM I VOTING TO BUILD A NEW TOWN OFFICE?

**NO.** This vote only authorizes the Select Board to develop a design for a new Town Office, including an estimate for construction costs. Any completed design would still need to be approved by voters in a subsequent vote before it could be funded and before any construction could begin.

#### WHY NOW?

- In February 2017, the Town Office Renovation Committee concluded that renovating the Town Office would be "ineffective and a waste of money."
- The committee cited several factors, including:
  - a) high utility and building maintenance costs
  - b) inadequate storage for vital records
  - c) inadequate office and vault space
  - d) inefficient structure and layout;
  - e) the expense of bringing the facility into compliance with ADA standards
- Recent studies have identified issues with mold and poor air quality throughout the building.

#### WHY AM I VOTING WHETHER OR NOT TO REPEAL THE NOVEMBER 2015 VOTE?

- In order to consider other options for the Town Office, voters must repeal a section of the November 2015 referendum vote. That section mandates the retention and renovation of the Town Office at its existing location.
- Town officials are currently evaluating whether building a new Town Office on the Memorial School site in conjunction with the proposed Wescustogo Hall and NY Community Center would result in savings in labor, construction, and financing costs.
- Repeal would also allow the Town to consider other options for the current Town Office site, such as selling the property and putting the funds toward the proposed plan for redevelopment of the Memorial School site.

#### WILL THIS INCREASE MY TAXES?

Using funds from the town's unassigned fund balance will not increase your property taxes.

#### **New Dispatch Services**

As of July 1, 2017, North Yarmouth Fire Rescue and North Yarmouth Public Works switched dispatch services from the Falmouth Communications Center to the Cumberland County Regional Dispatch Center located in Windham Maine. Cumberland County Regional Dispatch Center provides both Emergency and Non-emergency dispatching services for many public service agencies located in Cumberland County. Cumberland County Regional Dispatch Center also serves as the Public Safety Answering Point (PSAP) for 19 of the 28 communities within Cumberland County. Cumberland County Regional Dispatching agency for the Cumberland County Sheriff's Office (which is our police agency).

Changes you may take notice of:

- 1. The Non-emergency number has changed. Please call 207-893-2810 for any nonemergency complaints
- 2. Monitored Fire and Burglar Systems: If you have a monitored fire and/or Burglar system, please make contact with your alarm company to ensure the call goes to the correct dispatch center. This will ensure that delays are not added to the dispatch process. The correct number is 207-893-2810
- 3. Life-Alarms: If you have a monitored life alert system, please make contact with your alarm company to ensure the call goes to the correct dispatch center. This will ensure that delays are not added to the dispatch process. The correct Phone number is 207-893-2810



# Learn about Cumberland County's CodeRED campaign to urge citizens to enter their cell phone information into the CodeRED and be notified of emergencies in their area.

Cumberland County Public Safety agencies have engaging with stakeholders across the County to increase the number of people who sign up or download CodeRed onto their phones. CodeRed is the emergency alert system used by all Public Safety agencies within Cumberland County to notify residents of emergencies in the area. Stakeholders who have committed to encouraging their employees, clients, families and friends to take this preparedness action include Cumberland County Emergency Management, Town of Scarborough, City of Westbrook, Maine CDC, Windham Fire-Rescue, American Legion #148, Bridgton Police Department, Cumberland Police Department, Sappi, North Yarmouth Fire Rescue as well as several school departments. Additional stakeholders are signing up for this effort.

During the last two weeks in July and first week in August this group of stakeholders will be using their existing communications channels and being creative to encourage their stakeholders to take this emergency preparedness action.

In tandem, the City of Portland is doing the same effort. Stakeholders participating in the City include City of Portland Emergency Management Agency, United Way of Greater Portland, West End Neighborhood, Portland Convention and Visitor's Bureau, Portland Housing Authority, Portland Downtown District, and many other stakeholders are in the process of signing up.

An estimated total of 80,000 are expected to receive this message and take action to register with CodeRed. Dinner is in the fire station between the hours of 5pm and 6:30pm.






## **Planned for Oct 7th**
