

## Low Cost Life-Saving Defibrillators Now Available to Town Businesses

#### **Opportunity to Purchase AEDs at Reduced Price for North Yarmouth Businesses**

Sudden cardiac arrest (SCA) is one of the leading causes of death among adults over theage of 40 in both the United States and other countries. In the U.S. alone, approximately 326,200 people of all ages experience out-of-hospital non-traumatic sudden cardiac arrest each year; 9 out of 10 of these victims will die. In fact, SCA is so prevalent that the number of people who die each year is roughly equivalent to the combined number of people who die from Alzheimer's disease, assault with firearms, breast cancer, cervical cancer, colorectal cancer, diabetes, HIV, house fires, motor vehicle accidents, prostate cancer and suicides.

SCA is a life-threatening condition—however; survivability can be significantly increased with early intervention using cardiopulmonary resuscitation (CPR), defibrillation, advanced cardiac life support, and automatic external defibrillators (AEDs). Today, without bystander intervention, a dismal 5% - 7% of people who experience an out-of-hospital sudden cardiac arrest survive. CPR and AED application by bystanders prior to EMS arrival can increase the victim's chances of survival by up to 50%.

Because heart disease continues to be the nation's leading cause of death, North Yarmouth Fire Rescue has launched a program to reduce heart damage, increase survivability and improve the quality of life of individuals who experience a heart attack, sudden cardiac arrest, or stroke.

On March 3, 2015, the town of North Yarmouth was designated a HeartSafe Community. The Maine HeartSafe Community program is a cooperative initiative between the Maine Emergency Medical Services (EMS) Offices and the Maine Cardiovascular Health Council (MCHC). The program recognizes local efforts made to provide strong cardiovascular-related emergency care for residents and visitors and promotes partnership between local EMS services and community partners to improve overall cardiovascular health and awareness.

## While the scope of the program may expand in the future, today it includes the following components:

• An on-going community awareness campaign during fire prevention week and other

community functions

• A public access automatic external defibrillator (PAD) program; providing AED's to businesses in town at extremely discounted prices and free training on use of the AED for the business purchasing the AED

- A public link to the local emergency medical dispatch system (for emergency dial 911)
- First responders and Advanced Life Support (ALS) with heart safe enhancements (ie, endotracheal intubation, fluid replacement, and medication administration, cardiac monitoring, and defibrillation)
- A strong relationship with our local hospitals and emergency departments
- Early Stroke Recognition by our dispatchers and EMS providers

North Yarmouth Fire Rescue has partnered with the Maine Cardiovascular Health Council and LIFESAVERS, INCto provide our businesses the opportunity to place AED's in the workplace at a discounted rate. Typically an AED costs between \$1250.00 - \$1500.00 per unit. North Yarmouth Fire Rescue has been authorized to offer a Defibtech Lifeline (model DDU-100) AED w/5yr battery pack, adult pads, manual, warrantee, and quick use card for \$675.00. We can also purchase numerous accessories at extremely discounted prices.

#### What is an automated external defibrillator?

An AED is a portable user-friendly electronic device that automatically diagnoses potentially life-threatening heart rhythms. If the AED detects a problem that may respond positively to an electric shock, it permits a shock tobe delivered to restore a normal heart rhythm. AEDs provide simple audio and visual instructions and are designed for use by laypersons. Some AEDs advise the operator to press a button to deliver the shock. Other AEDs automatically provide a shock if the heart is in a fatal rhythm.

## Is a rescuer protected from legal liability risks if he or she uses an automated external defibrillator?

The overwhelming majority of U.S. jurisdictions afford some type of legal liability protection for AED users. Often, these protections are provided by Good Samaritan statutes. Typically, AED users are protected from liability so long as they act in a reasonable and rational manner. Liability protections generally don't cover gross negligence or willful or wanton misconduct.

#### Can a rescuer accidentally hurt the victim with an automated external defibrillator?

No. The victim is already clinically dead and the rescuer's actions can only help. AEDs are designed to resuscitate people whose hearts have stopped working effectively. AEDs will only shock victims whose hearts need to be shocked to restore a healthy rhythm.

#### Can a rescuer hurt himself or others with an automated external defibrillator?

No, not if the AED is used properly. The therapeutic shock is programmed to go from one electrode pad to the other through the victim's chest. Basic precautions, such as not touching the victim during the shock, ensure the safetyof rescuers and other bystanders.

#### Can automated external defibrillators be used to treat children?

Yes. For children under age eight, a of dose of electrical therapy should be used if possible. Some AEDs have pediatric capabilities. If a child's heart rhythm is potentially fatal and a device with pediatric capabilities is not available, a standard AED should be used.

In the town of North Yarmouth, the chances of surviving a life threatening cardiac event are rapidly improving thanks to our new HeartSafe initiative. The North Yarmouth Fire Company is a group of current and former members of the North Yarmouth Fire Rescue Department. The fire company has purchased and donated four AED's to the North Yarmouth Fire Rescue Department. This means that every piece of fire rescue apparatus that the town of North Yarmouth owns will be equipped with an AED, including the Fire Rescue Chief's vehicle. Public Works will be purchasing and placing two AED units in service. One will be placed in the Public Works Foreman's vehicle and the other will be located at the Public Works main office.

#### **Terms and Conditions of Open Burning**

- You must be at least 18 years of age to obtain an Open Burning Permit.
- Permits will only be issued on Class 1 or 2 days.
- Permits will be issued after 09:00. The State of Maine does not releasing the Class Day until 09:00AM everyday.
- All Open Burning Permits are only valid for one day and must be extinguished by Midnight
- It is illegal to burn without a permit in the state of Maine.
- We ask that you fill out a permit for campfires. This helps our dispatch center inform callers of why there may be smoke in the area of the address that is being called in about.
- You must print and sign your permit
- A hard copy of the permit must be in hand at all times during open burning
- If fire department receives any type of complaint about the burning, we are obligated to investigate and may potentially extinguish fire.
- All fires must be extinguished on the permitted date and by the end time listed on the permit.
- You may not start a fire with any type of accelerant.
- You must be in attendance of your fire at all times.
- Common materials that you cannot burn may include but not limited to are: paper, cardboard, plastics, chemicals, rubber, tires, pressure treated or finished wood, painted wood, rubbish or garbage, demolition debris such as insulation, Styrofoam, metal, sheetrock, asphalt shingles, or wire insulation.
- Burning prohibited materials or in violation of other permit restrictions may result in extinguishment of your fire, ineligibility for future permits and/or a summons to appear in court.

#### **Reminder: North Yarmouth Does Not Permit Fireworks**

Special Town Meeting- Article 2

October 18, 2011

#### TOWN OF NORTH YARMOUTH FIREWORKS ORDINANCE

#### Section 1. Title and Authority.

This ordinance shall be known as the "Town of North Yarmouth Fireworks Ordinance." It is adopted pursuant to the enabling provisions of the Maine Constitution, the provisions of 30-A M.R.S.A. § 3001, and the provisions of 8 M.R.S.A. § 223-A

#### Section 2. Definitions in accordance with 8 MRSA 221-A, sub 1-A.

Consumer Fireworks. "Consumer fireworks" has the same meaning as in 27 Code of Federal Regulations, Section 555.11 or subsequent provision, but includes only products that are tested and certified by a 3<sup>rd</sup>-purty testing laboratory as confirming with United States Consumer Product Safety Commission standards, in accordance with 15 United States Code, Chapter 47. "Consumer fireworks" does not include the following products:

- A. Missile-type rockets, as defined by the State Fire Marshal by rule;
- B. Helicopters and aerial spinners, as defined by the state Fire Marshal by rule; and
- C. Sky rockets and bottle rockets. For purposes of this paragraph, "sky rockets and bottle rockets" means cylindrical tubes containing not more than 20 grams of chemical composition, as defined by the State Fire Marshal by rule, with a wooden stick attached for guidance and stability that rise into the air upon ignition and that may produce a burst of color or sound at or near the height of flight.

Fireworks" means any:

- A. Combustible or explosive composition or substance;
- B. Combination of explosive compositions or substances;
- C. Other article that was prepared for the purpose of producing a visible or audible effect by combustion, explosion, deflagration or detonation, including blank cartridges or toy cannons in which explosives are used, the type of balloon that requires fire underneath to propel it, firecrackers, torpedoes, skyrockets, roman candles, bombs, rockets, wheels, colored fires, fountains, mines, serpents and other fireworks of like construction;
- D. Fireworks containing any explosive or flammable compound; or
- Tablets or other device containing any explosive substance or flammable compounds.

The term "fireworks" does not include consumer fireworks or toy pistols, toy canes, toy guns or other devices in which paper caps or plastic caps containing 25/100 grains or less of explosive compound are used if they are constructed so that the hand cannot come in contact with the cap when in place for the explosion, toy pistol paper caps or plastic caps that contain less than 20/100 grains of explosive mixture, sparklers that do not contain magnesium chlorates or perchlorates or signal, antique or replica cannons if no projectile is fired.

#### Section 3. Sales Prohibited.

No person or group may sell, possess with the intent to sell or offer for sale consumer fireworks or fireworks.

#### Section 4. Use Prohibited.

No person or group of persons shall use, display, fire or cause to be exploded fireworks or any of said items enumerated in Section 38-101 "Consumer Fireworks."

#### Section 5. Fireworks Display.

A fireworks display requires a permit from the Maine Commissioner of Public Safety or his or her designee under the provisions of 8 M.R.S.A. §§ 221 – 237, and particularly section 227-A. The Fire Chief, or his or her designee, shall inspect the proposed display site at the time of the inspection conducted by a representative of the Maine Public Safety Department under 8 M.R.S.A. § 227-A(2).

#### Section 6. Use Prohibited Within Fifty Feet of Public Way.

No person shall use, display, throw, drop or cause to be discharged or exploded, any consumer fireworks or fireworks at any time, within fifty feet of any public way.

#### Section 7. Civil Penalties.

Whoever violates any of the provisions of the foregoing Sections shall be subject to a civil penalty of not less than one hundred dollars (\$100) per day and not more than twenty-five hundred dollars (\$2,500) per day, plus attorney's fees and costs.


