## **North Yarmouth EDSC Overview and Summary of Resources**

North Yarmouth operates under the "Town Meeting" form of government.

Select Board members (5) are elected to staggered 3-year terms which expire June 30th of their expiration year. The Select Board convenes an annual Town Meeting in April for voters to decide on the budget and other warrants. Annual municipal elections are held each June to elect town officials, including Select Board members, Yarmouth Water District Trustee, Directors of MSAD #51, Budget Committee and Cemetery Commission. All other town committee membership is through appointment by the Select Board.

The Select Board currently holds bi-monthly meetings, on the 1<sup>st</sup> and 3<sup>rd</sup> Tuesday of each month. They operate meetings using Roberts Rules. Roberts Rules adds structure to conducting business, however it is not a requirement of the Town Charter. Each meeting agenda includes time for public comment.

The North Yarmouth Town Charter (9 pages) defines the town structure of roles and responsibilities. This includes the powers and duties of the Select Board. The Select Board is charged with the administrative and executive function of the town. A Town Manager is chosen by the Select Board and has defined roles and responsibilities as detailed in the Town Charter. Additionally, the Town Charter defines the various elected boards, commissions, committees and officials. The **Land Use Ordinance** is the governing legal document (287 pages currently) which dictates the rules for all new building in North Yarmouth. It is complex and technical and used by the Planning Board in review and approval of applications for building and development. Section 10.4 on pages 130 – 218 include specific Building Standards. **Development** was prepared by Maine Design Workshop in collaboration with the EDSC. It is a guiding document to be used by boards and committees to shape future zoning and land use policy decisions, support review of municipal and private development projects and support investment into public buildings, spaces and streets. It presents an illustrative long-term vision for the town applying the design principles and strategies to both public and private land. The document (46 pages) includes a sketch of condensed tall buildings in the village "triangle" which was included in the June 2021 Annual Town Meeting materials and a framework for the Land Use Ordinance. The **2017 Economic Development Strategy** report (34 pages), (also referred to as the **Camoin report**) was prepared in March 2017 by the consulting firm Camion Associates.
