This walk was truly one magical exploration after another.

Another friend recently took me to Baston Park and I didn't recognize it. Many years ago, I'd attended a dedication ceremony honoring Richard and Roslyn Baston here. When I went again this fall, I saw the immense labors of some of North Yarmouth's most committed residents working alongside the North Yarmouth Public Works Dept. The park has been cleared of invasive bittersweet and it is pristine; a perfect place for a quiet picnic!

Very soon, I will walk the Sam Ristich Trail, right in the Village Center! I've done the beginning of it, but there is much more... I remember going to a talk many years ago by Sam Ristich about mushrooms!

I have enjoyed winter walks in many of our town parks

navigating snow, ice, streams...pondering what footwear is best for today? It's also been fun to find some of the greens (princess pine and winterberry, for instance) that, as a girl, I used to gather with my mother to make wreaths.

Now, as the days grow longer and the sun is warmer, my walking friends are beginning to tell me what we will see on our spring walks...the bobolinks, the warblers and the

grackles will be here, we'll see kites in the sky, find strangely beautiful mushrooms and, my personal favorite the wild flowers will bloom.

In the summer, hopefully the picnic tables will return from the pandemic-required warehouse.

Town parks have helped my friends and me stay in social contact safely and helped us maintain our emotional health.

First Greeter

The First Greeter Program, under the auspices of The Living Well in North Yarmouth Committee, made its first First Greeter contact in 2017. Since then,162 new residents have been contacted - 62 since January 1, 2020.

First Greeter activity slowed in early 2020 (even pre-Covid), but in November, Tracey Cox, from the Code Enforcement Office, supplied us with a list of over 200 recent property transfers. With the help of Deb Grover, we determined that up to 40 new residents made North Yarmouth their new home between May 2020 and October 2020.



Many of the new residents live in the village center, but just as many were sprinkled through other parts of town.

Cheryl Trenoweth, from the town office, pulled together the contents for 40 new Greeter bags,, quickly assembled by LWNY members and delivered by the Greeters.

Response from new residents was positive and some new relationships were created -electronically and Covid safe. The First Greeter program is now awaiting transfer deed information for November - December 2020.

Assessor's Office

2021 Business Personal Property Tax

All businesses are required to provide the Assessor with a true and perfect detailed list of all the business assets located at your place of business as of April 1, 2021. The State of Maine law provides that the personal property associated with a business is subject to property taxation. The tax is assessed annually in accordance with the requirements set forth in Title 36 of the Maine Revised Statutes, sections 601 & 706A.

- Requests for the business personal property tax forms will be mailed by the first week of March.
- Filing deadline is April 15
- An extension request can be submitted in writing (via email or mailed)

Tax Relief Reminders

Maine Homestead Property Tax Exemption of \$25,000 This exemption is a FREE tax relief program offered by the State of Maine to any homeowner who owns and has lived in their primary residence continuously for 12 months prior to the application.

• Filing deadline is April 1

Maine Veterans Property Tax Exemption

If you are a Maine resident and a veteran who served on active duty in the U.S. Armed Forces, you may be eligible for a limited exemption from property tax on real estate or personal property. You qualify for an exemption if:

- You are a paraplegic.
- You are receiving a total disability pension from the U.S. Government OR
- You served in the U.S. Armed Forces during a recognized war period or other recognized service period or you received an Armed Forces Expeditionary Medal; and you will be at least 62 years old on April 1.
- Filing deadline is April 1
