

**WARRANT AND NOTICE OF ELECTION
TO CALL MAINE SCHOOL ADMINISTRATIVE DISTRICT NO. 51 REFERENDUM
(20-A M.R.S. §§ 1501-04)**

TO: Debbie Allen Grover, a resident of Maine School Administrative District No. 51, composed of the Towns of Cumberland and North Yarmouth, State of Maine.

In the name of the State of Maine, you are hereby ordered to serve upon the municipal clerks of each of the municipalities within Maine School Administrative District No. 51, namely, the Towns of Cumberland and North Yarmouth, an attested copy of this warrant and notice of election. Service shall be in hand within three (3) days of the date of this warrant and notice of election. The municipal clerks of the above municipalities shall immediately notify the respective municipal officers. The municipal officers shall meet forthwith and countersign this warrant and notice of election. The municipal officers shall provide below for the respective municipal clerks to post or have posted this warrant and notice of election.

TO: Debbie Allen Grover, Municipal Clerk of the Town of North Yarmouth: You are hereby required in the name of the State of Maine to notify the voters of this municipality of the election described in this warrant and notice of election.

TO THE VOTERS OF THE TOWN OF NORTH YARMOUTH: You are hereby notified that a Maine School Administrative District No. 51 referendum election will be held at the Wescustogo Hall & Community Center, 120 Memorial Highway in the Town of North Yarmouth on Tuesday, November 8, 2022 for the purpose of determining the following question:

Question 1: Do you favor authorizing the school board of Maine School Administrative District No. 51 ("MSAD 51") to issue bonds or notes in the name of MSAD 51 in an amount not to exceed \$73,963,939 to construct and equip a new primary school and related site facilities to serve Grade pre-K through Grade 2 (the "New Primary School Project") at the location in North Yarmouth described below; to acquire and convey such easements and other real estate interests as the school board deems necessary as part of the New Primary School Project; and to renovate, improve, and reconfigure the Mabel I. Wilson School building and site facilities to serve Grade 3 through Grade 5?

New Primary School Project Location: The New Primary School Project serving Grade pre-K through Grade 2 will be located on approximately 76 acres of land on the southwest side of Gray Road in North Yarmouth. MSAD 51 holds an option to purchase this land from Construction Aggregate, Inc. and Benjamin C. Grover pursuant to an option agreement dated October 26, 2021. The school board may also acquire and convey easements and other real estate interests to develop the New Primary School Project site.

The polls must be opened at 7:00 A.M. and closed at 8:00 P.M.

The Registrar of Voters will hold office hours while the polls are open to correct any error in or change a name or address on the voting list, to accept the registration of any person eligible to vote, and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.




